

**Instructions for Corporate Shareholders
For participating and voting
at the Annual General Meeting of ANGLER GAMING plc on 7th June 2018**

1. Where a corporate shareholder participates in a general meeting of Angler Gaming plc, such shareholder may be represented by its corporate duly authorised representative.
2. A representative, to be considered a duly authorised representative of the company-shareholder, must be authorised by means of a resolution of the shareholder's board of directors or other governing body authorising such representative to act as she/he thinks fit at the shareholders' meeting. The resolution must be made on the shareholder's letterhead and contain the name, position and passport number of the authorised representative. The resolution must contain a statement that it is made in accordance with applicable laws and the shareholder's corporate constituting documents. Alternatively, certificate of registration or equivalent document evidencing the representative's authority to represent the shareholder may be provided.
3. A scanned copy of the said resolution or other document evidencing the representative's authority to represent the shareholder must be sent to agm@anglergaming.com
4. The originally signed resolution or other document evidencing the representative's authority to represent the shareholder must be sent to

And must reach the Company by not later than 12:00 on 4th June 2018.

5. A duly authorised representative must also present his personal identification document for verification purposes.
6. In case a duly authorised representative would like to appoint a proxy, a PROXY Form should be submitted. In such case, please follow instructions stated in the PROXY Form.
